The end result is a haz-mat clean up that closes the marina and the channel for the rest of the day. End result, no flipper watch or evening fishing trips since marina is closed for clean up; cost \$2465. The boat has not been seen since. And then there was the Big Dog.

She sank by the dock on the channel. The owner had no insurance and pled poverty. Cost for salvage and clean up \$14,000 and change. You don't even want to think about the cost to settle some lawsuits from people that've fallen on the boat ramp. They could run a million or better in medical claims. Back in June, Great American Insurance Company informed Darrell

that they would no longer insure the public boat ramp because of the liability and the fact that the public ramp had no relationship with the normal operations of the Sea Ranch Marina. It seems germane to note that the above claims were never even submitted to the insurance company for payment. Had the Sea Ranch not closed the ramp they would've breached their concession agreement with the county by not providing liability insurance for all their operations. Self-insuring is not an option. Lawyer fees alone run \$350 bucks an hour and they can't subject a \$4.5 million-dollar asset to that kind of exposure. The county also tried and failed to find an insurer for the public boat ramp. As it stands now, the only folks that can use the ramp are the Coast Guard and the other concessionaires on an appointment basis because they too
